- Develop and maintain firmware and software test automation frameworks and infrastructure for Software Quality Engineering and Firmware Development

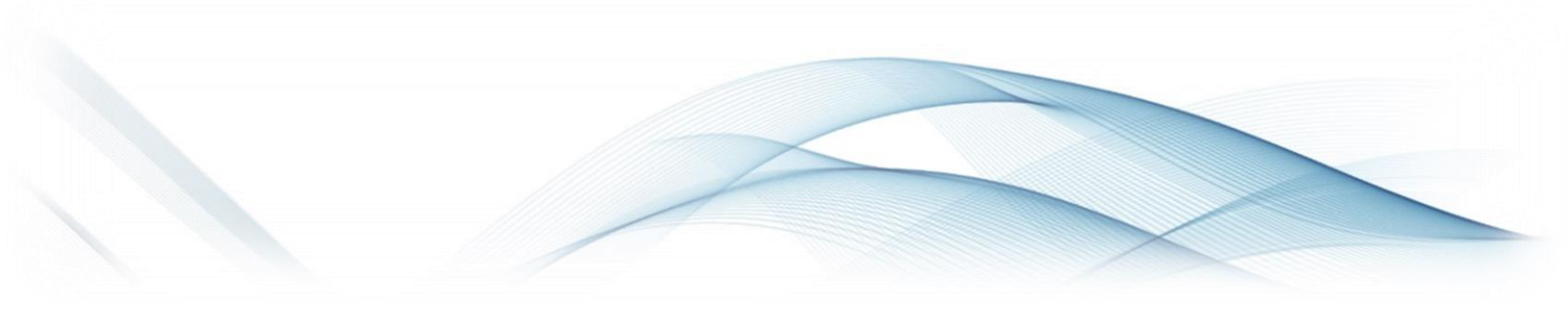

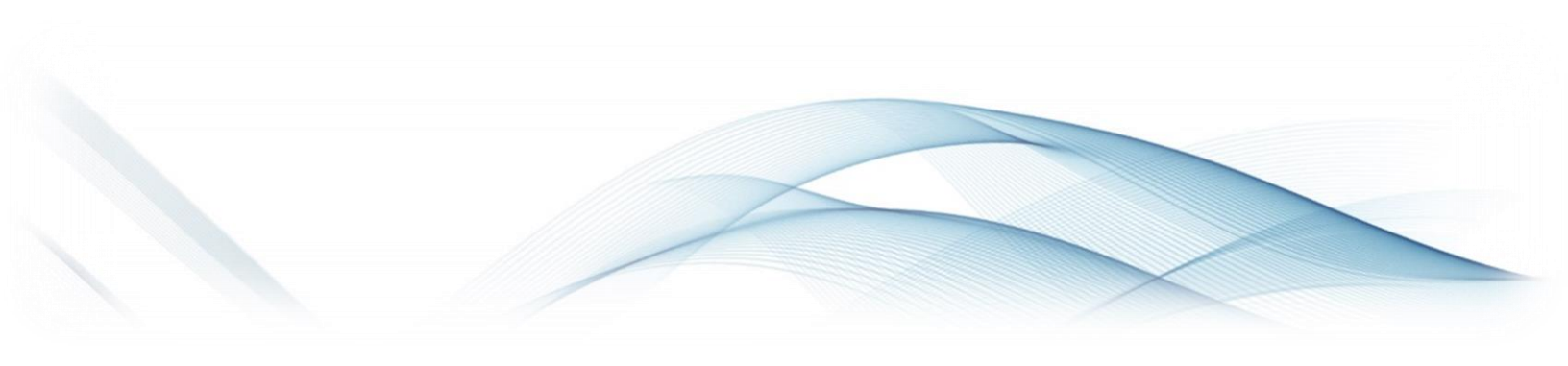
